As a Participant in the **First Nations Conservation Program** you consent to the collection, use and disclosure of your personal information by **Hydro One Networks Inc.** and the IESO in connection with the **First Nations Conservation Program** including for purposes of reporting, follow-up surveys, studies and audits, and the provision to the IESO of your past and current energy usage for such purposes (as well as disclosure to the Ontario Energy Board, the Ontario Ministry of Energy and/or the Ontario Environmental Commissioner or their respective successors.) You understand that in connection with surveys, studies and audits, the IESO may contact you directly, including by email and other electronic communication.
